Artists are invited to submit two-dimensional work for the Third Annual Juried Show at the Village Art Circle in Cary, North Carolina. Artists may interpret the show title "Carolina On My Mind" in any way, from representational art to abstract art and in any medium.

Sales

- All work must be available for sale and ready to hang if juried into the show.
- A 30% commission is kept by the Village Art Circle on all sales.

Terms & Conditions

Liability: Village Art Circle LLC (VAC) will take every precaution against damage or theft, but will not be responsible for loss whatever the cause. Exhibiting artists must provide their own insurance coverage. VAC reserves the right to decline any entry of withdraw any entry from the exhibition at its discretion. Digital images become property of VAC for promotional purposes. VAC also reserves the right to photograph and reproduce any artwork submitted for educational or promotional purposes. The juror's decisions will be final. Entry fees are non-refundable. Submission of an entry to the exhibition constitutes agreement of the artists to all terms and conditions in this prospectus. VAC members are prohibited from entry.

Entry Information

Nonrefundable Entry fee: **\$25 for up to two entries.**

- Up to two 2-D works per artist may be submitted. Since this is a juried show, not all entries will be exhibited. Only one work per artist could be accepted into the show.
- Size of work: no larger than 30 inches by 36 inches in either direction (including frame).
- Images of work **MUST** be submitted digitally. Submit as JPEGs, either by email attachment (preferred) or on CD. Minimum resolution is **300 dpi**. Please title each JPEG file entry with your last name, first name and either #1 or #2. For example:

SmithJohn#1 or SmithJohn#2

- No digital enhancements for paintings.
- Image(s) must show work without mat or frame.
- Online registration (preferred method): See www.villageartcircle.com for email submission. Click on "Online Registration Steps" to proceed with online registration, submission of digital images by email and payment via Paypal.
- By submitting the registration online, the artist is verifying that he/she agrees to ALL TERMS & CONDITIONS as stated in this prospectus.
